



# **IWK Research & Innovation Advisory Committee**

# **Terms of Reference**

#### **Purpose**

The IWK Research and Innovation Advisory Committee (IWK-RIAC) is an advisory committee to the IWK. The purpose of the IWK-RIAC is to advise on research and innovation capacity and impact at the IWK. The IWK-RIAC is a forum for members of IWK departments and research centres located at the IWK to provide advice to inform:

- 1) Research and innovation strategy development at the IWK.
- 2) Opportunities to enhance and facilitate research and innovation at IWK.
- 3) Communication regarding research and innovation at IWK.

Advice provided by the IWK-RIAC shall be considered by the IWK Vice-President Research & Innovation (VPRI) and the Executive Leadership Team.

## **Functions/Responsibilities**

The IWK-RIAC will:

- 1) Advise on research and innovation strategy, including strategic, institutional research goals, including:
  - a. Annual report on strategic goals and indicators.
  - b. Annual report on internal and external grant programs.
- 2) Advise on establishing and monitoring indicators of research and innovation strategy outcomes.
- 3) Advise on identifying opportunities to develop, enhance and facilitate research and innovation at IWK, including:
  - a. Annual review of programs, program development, implementation, devolution.
  - b. Collaboration with industry, universities, government, and other partners.
  - c. Identifying and advising on obstacles to research and innovation.
  - d. Advise on ways to enhance and facilitate data access, management and sharing, to better support research and innovation.
- 4) Facilitate communication within and across departments and research centres located at IWK.
  - a. This includes the expectation that RIAC members will reach out to people for input and disseminate information to people.

#### **Committee Composition**

- 1) The IWK-RIAC Chairperson is appointed by the IWK President/CEO. The IWK-RIAC Chairperson is the VPRI.
- 2) Members are appointed by the IWK President/CEO upon recommendation from IWK VPRI. Appointed members reflect a breadth of IWK research and innovation experience and disciplines, as well as equity, diversity, inclusion, reconciliation, and accessibility (EDIRA) principles. Members will serve a term of up to 3 years, renewable once. Trainee members will serve a term of up to 2 years. Members are ex-officio, except Members-at-large. Members are non-voting. The IWK-RIAC composition includes (members can represent more than one position):
  - a. Directors of Research of IWK Clinical Departments (up to 3 members).
  - b. Directors of IWK Research Centres/Groups (up to 3 members).
  - c. Members-at-large (up to 3 members), including IWK researchers with significant University links and reflecting a range of career stages.

- d. Trainee with significant research and/or innovation commitment (1 member).
- e. IWK Research & Innovation Advancement Director (1 member).
- f. IWK Innovation lead (1 member).

## **Committee Support**

The administrative assistance support to the IWK-RIAC is supported by the office of the VPRI.

#### Quorum

50%+1 of membership shall constitute quorum.

#### **Meeting Schedule**

The IWK-RIAC shall meet on a quarterly basis or at the request of the Committee Chair.

#### **Committee Evaluation**

The committee will annually review its mandate and will undertake an annual self-assessment of its performance. The Committee Chair will provide a report of the annual self-assessment of the IWK-RIAC to the IWK Executive Leadership Team.

#### **Decision Making**

The IWK-RIAC provides recommendations and advice.

#### Reporting

The VPRI will provide a report of IWK-RIAC's activities to the IWK Board of Directors annually, or as required.
